**1. Eligibility:** Apply with offer code FRIEND50. This offer is available to new to St. Mary's Bank individuals opening their first St. Mary's Bank checking account. If you have been a primary or secondary holder of a St. Mary's Bank checking account within the last six months, you are not eligible for this bonus. Referred party must (a) be a new a new to St. Mary's Bank member, (b) open a new St. Mary's Bank checking account as the primary owner, and (c) establish a minimum \$250 recurring direct deposit within 60 days of account opening. A direct deposit is a recurring income electronically deposited into your St. Mary's Bank checking account by an employer or other organization. It may include salary, pension, government benefits, or other eligible regular income. Certain money transfers, such as person-to-person payments and payments made with apps such as Zelle®, PayPal, or Venmo, do not qualify as direct deposits. Transfers between accounts at St. Mary's Bank, or other banks or brokerages also do not count as direct deposits. A minimum deposit of \$10 is required to open a St. Mary's Bank checking account. Account must be opened in person at any St. Mary's Bank branch location. Limit one \$50 Refer-A-Friend bonus regardless of how many checking accounts are opened by the referral party. By participating in this program, each party may be aware that the other is a St. Mary's Bank member. **\$50 Bonus for Both Parties:** \$50 will be deposited up to 30 days after the new member's checking account (referral party) is opened **AND** the \$250 qualifying direct deposit is completed. The bonus will not be deposited if any account is in default, closed or suspended, or otherwise not in good standing. A referrer can receive up to 10 referral bonus deposits (totaling \$500) each calendar year. \$50 Refer-A-Friend offer ends December 31, 2024.
